Young Dairy Leaders Institute



Program Goals

Through interactive training sessions and working closely with industry experts and dynamic leaders, YDLI participants:

- Are prepared to take leadership roles in dairy organizations and their communities.
- Become effective spokespeople and advocates for the dairy industry with consumers and media.
- Understand current social, political, science, organizational and economic issues facing the industry and how to affect change.
- Develop the interpersonal communication skills and network needed to succeed in today's dairy business.

Participant Selection Guidelines

- Applicants will be actively involved in dairy production or closely-related agriculture.
- English-speaking individuals ages 22-45 may apply.
- No two members of the same immediate family will be selected to be in the program at the same time. (Immediate family defined to include: spouse, brother/sister, parent/child)
- Leadership ability and potential will be considered in the selection of participants. All applicants should have a desire to improve the dairy industry, and take on leadership roles in their organizations and communities in the future.
- Consideration will be given to interest and willingness of the participant to commit the required time, energy and finances for the program. Accepted candidates are expected to participate in the full 12-month program.

Time Commitment

- Phase I Four days for an on-site training session in, plus travel time
- Phase II (year between Phase I and Phase III) A number of days for completing projects and reporting results
- Phase III Four days for an on-site training session, plus travel time (Check Holstein Foundation's website, www.holsteinfoundation.org, for up-to-date information)
- Applicant must document that he/she will be able to be away from the farm, business, occupation and/or home as required for full participation in the program.

Funding and Costs

A \$500 tuition fee is charged to each participant to offset a portion of the costs over the 12-month duration of the program. Following notification of acceptance, the full fee (non-refundable) will be due with registration. Meals and program materials are included. Air and ground transportation, hotel and other incidental expenses are the participant's responsibility. Participants may seek sponsorship on their own to cover program attendance (e.g., from your employer, milk cooperative, feed supplier, etc.) Roommates will be arranged (unless a single room is requested) to help offset hotel expense.

The program is sponsored by the Holstein Foundation, a not-for-profit tax exempt 501(c)3 organization dedicated to developing dairy leaders. The Foundation relies upon businesses, foundations, organizations and individuals for operations support. The Holstein Foundation invests over \$4,000 in each YDLI participant.

Application & Selection

Applications must be received by August 1, 2018. Enrollment of the program is limited so more one-on-one instruction may be provided. Personal or phone interviews may be held by the applicant selection committee.
